FIRST AMENDMENT TO

DECLARATION OF COVENANTS AND RESTRICTIONS

<u>OF</u>

COUNSELOR'S CLOSE

THIS AMENDMENT to the Declaration of Covenants and Restrictions for Counselor's Close, is made this 19th day of July, 2004, by COUNSELOR'S CLOSE ASSOCIATES, a Virginia general partnership (hereinafter called "Developer") and COUNSELOR'S CLOSE COMMUNITY COMPANY, INC., a Virginia non-profit corporation (hereinafter called the "Company").

RECITALS

WHEREAS, by Declaration of Covenants and Restrictions made December 31, 1981 and recorded in City of Williamsburg Deed Book 61 Page 488, which were subsequently extended by three Extension of Declaration of Covenants and Restrictions made October 5, 1983, September 10, 1986, and March 29 1988, and recorded in City of Williamsburg Deed Book 65 page 159, Deed Book 76 page 581, and Deed Book 83 page 175, respectively (hereinafter collectively called the "Declaration"), Developer subjected certain lots located in the City of Williamsburg, Virginia particularly described in <u>Schedule A</u> attached hereto (hereinafter referred to as the "Property") to the covenants and restrictions set forth therein; and

WHEREAS, Article VII, Section 2 of the Declaration provides that it may be amended by an instrument of record after written consent thereto by the Developer and not less than sixty percent (60%) of the Owners shall have been obtained; and

WHEREAS, as evidenced by their written consents attached hereto as <u>Schedule B</u>, the Owners of more than sixty percent (60%) of the lots subject to the Declaration wish to amend the Declaration in certain respects.

AMENDMENTS

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. Article VII, Section 2 is hereby amended to read in its entirety:

<u>Section 2</u>. <u>Amendment</u>. The Declaration may be amended at any time by an instrument of record after the written consent thereto by not less than sixty percent (60%) of the Owners have been obtained.

2. There shall be added to Article V of the Declaration a Section 17 which shall provide:

<u>Section 17.</u> <u>Leasing of Units</u>. The leasing of Units shall be subject to such reasonable rules and regulations as may be established from time to time by the Company. The Company shall not have the right, however, to restrict, regulate or determine the term; rent or lessee under the lease of a Unit, except for the following:

- (a) Occupancy of all Units shall at all times be in accordance with the provisions of the Declaration.
- (b) No Owner shall lease a Unit for hotel or transient purposes or for a term of less than six month's duration.
- (c) No Owner shall lease less than all of a Unit.
- (d) No Owner shall allow a lessee of his Unit to sublease the Unit.
- (e) No more than ten percent (10%) of the total number of the Units constructed on the Property may be leased at a given time. The number of Units that may be leased based on this calculation is referred to as the "Rental Cap" for purposes of this section. In the event that calculation of the Rental Cap results in a fractional number, the Rental Cap shall be determined by rounding the fractional number down to the next whole number. Unit Owners desiring to lease a Unit shall make application to the Company pursuant to such rules and regulations adopted from time to time by the Company. The Company shall determine whether an Owner is eligible to lease a Unit

No Owner shall lease a Unit until the lease has been approved by the Company. The Company shall not withhold approval if an Owner's application to lease does not violate the Declaration, this Amendment or the rules and regulations set forth by the Company from time to time.

- (f) The Owner of record of a Unit on December 31, 2004 shall be exempt from the Rental Cap restriction of subsection 17(e) above. Any lease of a Unit pursuant to this exemption shall in all other respects be subject to the Declaration, this Amendment, and the rules and regulations issued by the Company.
- (g) Any Owner leasing a Unit shall promptly provide the Company with a copy of the written lease agreement pertaining to that Unit and such reasonable information as the Company requires with respect to the lessee under the lease.
- (h) The lease of any Unit must be in writing. A written agreement for lease of a Unit shall provide that the lease shall be subject in all respects to the Declaration and the rules and regulations issued by the Company and that any failure by the lessee to comply with the terms of those documents shall constitute default under the lease. An Owner leasing a Unit shall provide the lessee with a current copy of the Declaration and any rules and regulations issued by the Company. Any lessee of a Unit shall be bound by the Declaration, this Amendment, and the rules and regulations issued by the Company despite the failure of the Unit Owner to comply with this provision.
- All capitalized terms as used in this Amendment defined in the Declaration have the same definition as provided in the Declaration.
